

## Southern Lion TOP Golden Prosperity Contest Terms and Conditions

### A. Terms and Conditions of Entry

#### 1. Introduction

- 1.1 The Terms and Conditions of Entry are to be read together with the Schedule to the Terms and Conditions of Entry (collectively "**Terms and Conditions**").

<p><b>6. Contest Entries:</b></p>	<p>(a) The Eligible Participants/Winners of the Contest will be selected by the Organiser at random.
